Based on FIS's Annual Report on Form 10-K, the Compensation Committee of FIS determined that the performance criteria for 2019 had been met, resulting in vesting of the option as to 16,366 shares.
- 9. The restricted stock unit vests in three equal annual installments commencing on the first anniversary date of the grant.
