- In connection with Fidelity National Information Services, Inc.'s (the "Company") spin-off of Lender Processing Services, Inc. ("LPS"), one-third of the restricted shares of the Company's common stock held by reporting person have been cancelled and replaced with awards of LPS restricted shares having an equivalent intrinsic value and the same terms and conditions as the cancelled restricted shares.
- The option vests with respect to 1/16th of the total number of shares on the date of grant, with an additional 1/16th vesting on the last day of each succeeding fiscal quarter until fully vested, i.e., the option will be fully vested on December 31, 2008.
- In connection with Fidelity National Information Services, Inc.'s (the "Company") spin-off of Lender Processing Services, Inc. ("LPS"), one-third of the options to purchase the Company's common stock held by reporting person have been cancelled and replaced with awards of LPS options having an equivalent intrinsic value and the same terms and conditions as the cancelled options.
- The option vests in three equal annual installments beginning on the first anniversary of the grant date.
