- On March 29, 2018, the reporting person was granted performance restricted stock units ("PSUs") that vest in three equal installments contingent on FIS's satisfaction of certain performance criteria for each of the calendar years ending December 31, 2018, 2019 and 2020. The PSUs vest between 0% and 150% of the target grant amount in each year. The Compensation Committee of FIS determined the performance criteria for 2019 had been met, resulting in an award of 143% of the target grant amount.
- Represents shares to satisfy withholding tax obligation for PSU vesting.
- On March 29, 2019, the reporting person was granted performance restricted stock units ("PSUs") that vest in three equal installments contingent on FIS's satisfaction of certain performance criteria for each of the calendar years ending December 31, 2019, 2020 and 2021. The PSUs vest between 0% and 150% of the target grant amount in each year. The Compensation Committee of FIS determined the performance criteria for 2019 had been met, resulting in an award of 143% of the target grant amount.

6. Each restricted stock unit represents a contingent right to receive one share of FIS common stock.

7. The restricted stock units vest and distribute in three equal annual installments on each anniversary date.

8. On March 29, 2017, the reporting person was granted an option to purchase 39,277 shares of common stock. The option vests in three equal installments based on FIS's satisfaction of certain performance criteria for each of the calendar years ending December 31, 2017, 2018 and 2019. Based on FIS's Annual Report on Form 10-K, the Compensation Committee of FIS determined that the performance criteria for 2019 had been met, resulting in vesting of the option as to 13,093 shares.

9. The restricted stock unit vests in three equal annual installments commencing on the first anniversary date of the grant.

10. The option vests in three equal annual installments commencing on the first anniversary date of the grant.
